RESOLUTION 2021.18**



(Washington County Solid Waste District Board Appointment)

A RESOLUTION OF THE CITY COUNCIL OF TOQUERVILLE CITY, STATE OF UTAH, APPOINTING AND DESIGNATING A REPRESENTATIVE TO SERVE ON THE ADMINISTRATIVE CONTROL BOARD OF WASHINGTON COUNTY SPECIAL SERVICE DISTRICT NO. 1 FOR THE CALENDAR YEAR 2022 OR UNTIL SUCH TIME AS A SUCCESSOR HAS BEEN APPOINTED.

RECITALS

WHEREAS the Washington County Special Service District No. 1 ("District") was created by the Washington County Commission for the purpose of providing solid waste collection and disposal services for residents in Washington County, Utah, including the residents of Toquerville City, Utah ("City"); and

WHEREAS said District is governed by an Administrative Control Board made up of members appointed by the various cities and towns within the boundaries of the District; and

WHEREAS Toquerville City desires to designate a person to serve on said Administrative Control Board as the representative for City during the calendar year 2022 or until such time that a successor has been designated and appointed; and

WHEREAS all legal requirements pertaining to the designation of said representative have been met; and

WHEREAS the City Council of the City deems it necessary and desirable for the preservation of the public health, safety and welfare,

RESOLUTION

NOW THEREFORE BE IT HEREBY RESOLVED by the City Council of Toquerville City, Utah that Justin Sip a resident of Toquerville City, State of Utah, shall be, and is hereby appointed and designated to serve as Toquerville City's representative on the Administrative Control Board of Washington County Special Service District No. 1 for the calendar year 2022 or until such time that a successor has been designated and appointed.

BE IT FURTHER RESOLVED that this Resolution shall repeal and supersede all prior resolutions governing the same that are in direct contradiction hereto.

BE IT FURTHER RESOLVED that this Resolution shall become effective immediately upon approval and adoption by the City Council.
