ORDINANCE 2021.29



AN ORDINANCE OF THE CITY COUNCIL OF TOQUERVILLE, UTAH AMENDING AND RESTATING TITLE 1 - ADMINISTRATION, CHAPTER 6-3 MEETINGS TO REFLECT CITY COUNCIL MEETINGS WILL OCCUR ON THE FIRST AND THIRD WEDNESDAY OF EACH MONTH.

WHEREAS, Toquerville City ("City") is an incorporated municipality duly organized under the laws of the State of Utah;

WHEREAS, meeting schedules need to be updated from time to time; and

WHEREAS, the City Council wanted to foster consistency and transparency for applicants and meeting attendees to designate a specific day in the week to hold city council meetings.

ORDINANCE

NOW THEREFORE BE IT HEREBY ORDAINED by Toquerville City, Washington County, State of Utah, acting by and through the City Council as follows:

1. Amendment and Restatement of Section 1-6-3. Section 1-6-3 of the Toquerville City Code is hereby amended and restated in its entirety as follows:

1-6-3: MEETINGS:

- A. Regular Meetings: The City Council shall conduct at least one regular meeting per month, as provided in section 10-3-502(l)(b), Utah Code Annotated (1953, amended). Regular meetings shall be scheduled on the first and third Wednesdays, in the City Council Chambers located at 212 N. Toquer Blvd., Toquerville, Utah, commencing promptly at a time set by resolution, provided that:

1. Such meeting may be canceled or rescheduled by the Mayor and/or City Council if said meeting date is a legal holiday, or is immediately preceding or following such; and

2. The Mayor may cancel any meeting so long as at least one regular meeting of the Council is scheduled and held during the calendar month in which such meeting is canceled. Every meeting is open to the public, unless closed pursuant to Utah Code Annotated sections 52-4-204, 52-4-205, and 52-4-206.

2. Severability. If any section, clause or portion of this Ordinance is declared invalid by a court of competent jurisdiction, the remainder shall not be affected thereby and shall remain in full force and effect.

3. Conflicts/Repealer. This Ordinance repeals and restates all provisions of


Title 3, Chapter 1 of the Toquerville City Code and the provisions of any prior City ordinance in conflict herewith.

4. Effective Date. This Ordinance shall become effective immediately upon passage and the Mayor's execution hereof.
