**Payment:** The applicant agrees to pay monthly for the utility services rendered by Toquerville City. Payment responsibility remains with the applicant whether a bill is received or not.

**Delinquency:** The Utility Bill is due monthly by the 20<sup>th</sup> and shall become delinquent if not paid by that date. A penalty of 5% of the unpaid balance will be added to delinquent accounts. If any person fails to pay the water charges within thirty (30) days of the date due, the city shall give the customer notice in writing of intent to discontinue the service to the customer unless the customer pays the bill in full within five (5) days from the date of notice. If services are disconnected, a \$100.00 reconnect fee plus previous balance must be paid before services can be continued. \_\_\_\_\_ (initial)

**Reasonable Access:** The applicant shall permit the City's authorized representatives to enter on the customer's premises at all reasonable times for purposes connected with rendering, billing, or disconnecting utility services.

I hereby make application to the City utility department for service and guarantee payment for said service in accordance with rates and regulations in effect at time of delivery. I understand that in the event of default of the above policies, I agree to pay reasonable expenses of collection including all costs of collection agencies, attorney's fees, court costs and costs of preparing documents for court should it become necessary to use such measures to collect the charges made to the applicant's account. Toquerville City reserves the right to discontinue electricity, water, sewer, and/or garbage service if applicant is in arrears one month or more, after proper notice in writing or in person.
